CONDITIONAL PRIZE CONTEST

2/23/19

1. Sun Lakes Rotary & Healing Vets.Org will conduct the contest on the above listed dates for a chance to win the following grand prize:
 - a. 2018 Harley-Davidson Road King (max. value \$25,000.00)
2. Contest can be entered at Desert Wind Harley-Davidson beginning 2/23/2019. The grand prize contest will be held on 2/23/19.
3. (500) contestants will have the chance to win the grand prize Each contestant must select a maximum of one (1) playing card from each of the 5 selection stations. Contestants may select a maximum total of five (5) playing cards to comprise their hand. There will be a minimum of (52) unique standard playing cards available at each of the 5 selection stations. If a contestant successfully selects all five playing cards that exactly match the predetermined winning hand, that contestant will win the grand prize stated above – subject to verification by American Hole ‘n One Insurance. There will be a maximum of (1) winners. **If no contestant selects a hand that exactly matches their 5-card hand to the pre-determined winning hand, no grand prize will be awarded.**
